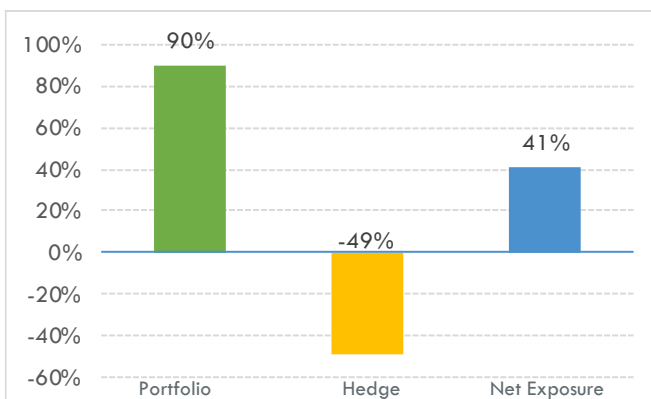

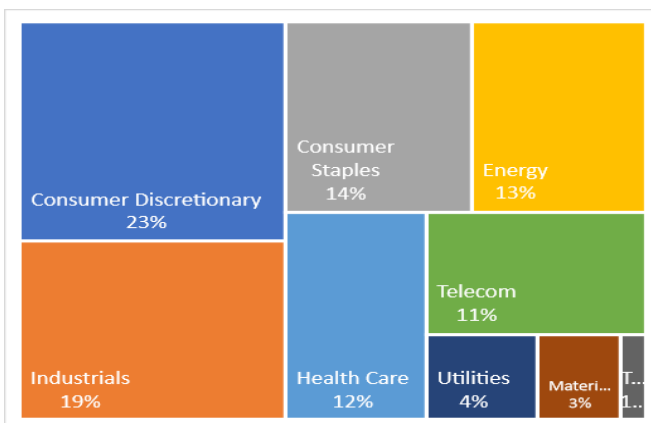

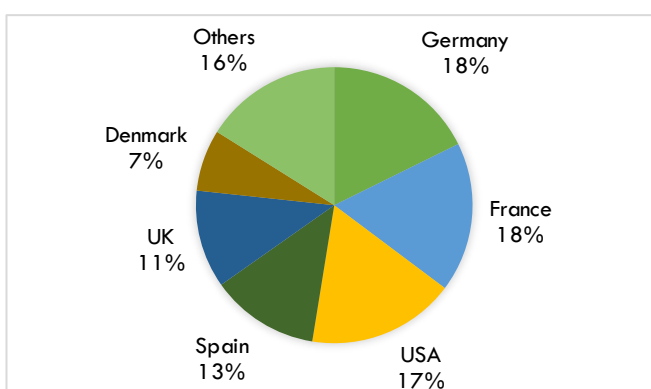
## Equity Exposure



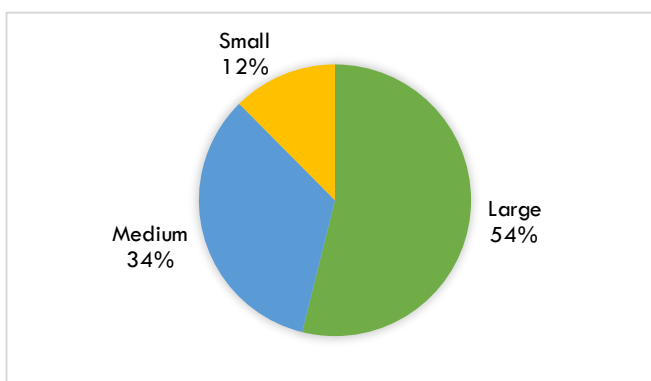
## Sector Distribution
